
AFFIDAVIT

The institutional building was constructed by the society on this very plot strictly in accordance with the building plan approved by CMO Nagar Palika vide orders dated 11/09/2015. The construction of institutional building was completed on this very plot on 138 Nagar Palika/2016 vide completion certificate dated 30/01/2016.



4- That, the institutional plot was well demarcated by raising boundary-walls/barbed-fencing on all four sides. The main gate of the institution is on Eastern/Western/Northern/Southern side and is well connected to NH-12, Hoshangabad Road through a barrier free approach road.



5- I do hereby certify that the visiting team had conducted the inspection of the proposed institution on that very address which the society had given in the application for recognition/permission.
